#### SWEARING IN OF COUNCILWOMAN AMY FLOOD

Town Clerk Brobston read the following resolution.

Resolution No. 29 of 2021, a resolution appointing Amy G. Flood to the Clifton Park Town Board.

Introduced by Councilman Morelli, who moved its adoption, seconded by Councilwoman Standaert.

WHEREAS, a vacancy exists on the Clifton Park Town Board due to the resignation of James Whalen, effective December 31, 2020, and

WHEREAS, pursuant to New York State Town Law Section 64 Sub 5, the Town Board has the authority to appoint an individual to the Town Board to fill such seat for the remainder of the 2021 calendar year, pending an election to be held in November 2021 for the remainder of Mr. Whalen's term, and

WHEREAS, Amy Flood, a Clifton Park resident, whose mailing address is 20 Meridian Lane, Ballston Lake, has indicated her interest in being appointed to the Town Board for the remainder of Mr. Whalen's term, and

WHEREAS, nearly two decades ago, Amy and her husband Jim chose to move to Clifton Park as the perfect place to raise their two children, and

WHEREAS, Amy Flood holds a Bachelor of Arts in Sociology from LeMoyne College, Master of Science in Public Management and a Master of Science in Elementary Education from Sage Graduate School, and is a long-time educator currently working as an elementary school teacher at Marie Curie Elementary School in the greater Amsterdam School District, and

WHEREAS, prior to answering a call to work as an educator, Amy Flood had a successful career in the private sector working for General Electric, as well as for a multinational pharmaceutical company, and

WHEREAS, Amy currently serves her community as an active member of the Crohn's and Colitis Foundation of America, a volunteer with Wreaths Across America at Saratoga National Cemetery, member of the Country Knolls Homeowner's Association, and as an active parishioner of Our Lady of Grace Church, and

WHEREAS, Amy Flood has previously served her community as parent volunteer with the PTA at Chango Elementary and Gowana Middle School, Faith Formation Leader for over a decade at Our Lady of Grace Church, and as a member of the leadership team for MOPS (Mothers of Preschoolers), and

WHEREAS, as a mother and educator, Amy has and continues to dedicate her time to strengthening and supporting Clifton Park youth; now, therefore, be it

RESOLVED, that Amy Flood has the experience and qualifications that makes her uniquely suited to be a member of the Clifton Park Town Board, and be it further

RESOLVED, that Amy Flood, 20 Meridian Lane, Ballston Lake, is hereby appointed to the Clifton Park Town Board through December 31, 2021, pursuant to New York State Town Law 64 (5); and be it further

RESOLVED, that the sum of \$ 15,538 be paid bi-weekly over the remainder of the year with a transfer from A-01010-E0334 (General Fund – Legislative Board – J Whalen) to A-01010-Exxxx (General Fund – Legislative Board – A Flood).
